*For highest consideration, it is recommended, but not required that grant applications for the '06-'07 school year be submitted by Sept. 30, 2006. To apply for a grant to benefit ISD 549, go to [www.549family.com](http://www.549family.com). Click on "Grant Application". Fill out the application online and click on the button to forward it to the principal of the PRIMARY building affected by the grant to begin the approval process. First time grant applicants need only fill out pages 3-6 and page 8. Applicants with a repeat request should complete only pages 7 & 8. Generally, a response from the 549 Family Advisory Board will be within 30 days of their receipt of the application. 549 Family cannot consider a grant without a completed application.*
